Instructor, at her sole discretion, reserves the right to exclude other people and animals from training.

PAYMENT OPTIONS:

Skye's Dog Training accepts the following forms of payment:

- PayPal
 - Owner may pay through PayPal while registering on-line.
- Check or money order by mail
 - If mailing check or money order, please make payable to "Skye's Dog Training" and send to Skye's Dog Training at address provided during Online Registration.
- Check, money order or cash in person
 If writing check or money order, please make payable to "Skye's Dog Training".

HEALTH & VACCINATION REQUIREMENTS:

Group Training: Dog must be free of communicable diseases and fleas at time of service as determined by the Instructor. In addition:

- Puppies 6 months and under must be current with Distemper and Parvo Virus vaccinations as appropriate to age; and
- Dogs 6 months and older must be current on Rabies, Distemper, and Parvo Virus vaccinations or have blood titer work done in lieu of vaccinations (rabies is still required in this case).
- *Please check with your vet at least 10 days prior to the class start date that the Dog is current on their vaccinations.

Private Training: Dog must be free of communicable diseases and fleas at time of service.

RATES:

MISSED CLASS POLICY:

Owner may choose to make up the missed week(s) with a private consultation, based on Instructor's availability, at a discounted rate of 25% off of the regular Private Consultation fee. More details on missed classes can be found on the Group Class Info Sheet.

REFUND POLICY:

No refunds will be given unless Instructor permanently cancels classes and/or lessons. No refund, in part or full, will be given if Owner and/or Dog misses or drops out of any class and/or lesson.

CANCELLATIONS:

Training may be cancelled or rescheduled by Instructor due to adverse weather, low class enrollment, catastrophic event, or for other reasons.

RECOMMENDATIONS & REFERRALS:

REMOVAL FROM TRAINING:

Instructor reserves the right to remove Dog from Group Training if Instructor determines Dog to be a threat of any kind to any animal or person. No refund will be given under such circumstances.

SEVERABILITY CLAUSE:

If a provision of this Agreement is or becomes illegal, invalid or unenforceable in any jurisdiction, that shall not affect:

- the validity or enforceability in that jurisdiction of any other provision of this Agreement; or
- the validity or enforceability in other jurisdictions of that or any other provision of this Agreement.

LIABILITY RELEASE:

Owner understands and agrees that participation in any dog training class or private consultation (inhome, at facility or over phone) is not without risk to Dog and/or Owner. Owner agrees that Skye's Dog Training and Instructor are not liable for any injuries or losses as a result of services provided now or at any future date. Owner agrees to take complete responsibility for the behavior and actions of Dog, him or herself, and any other person who accompanies him or her, before, during, and after services are provided by Skye's Dog Training.
